- Knowledgeable about all Ulster County resources with particular knowledge of the services of Access: Supports for Living.

- Be able to assess needs of each individual served and intervene as appropriate to the situation.
- Be able to coordinate outreach services, service planning, follow-up support and administrative back up as needed and clinically appropriate.
- Work in compliance with MMHT, agency and regulatory procedural guidelines.
