

Course: Care Management: Diabetes Webinar Series

Montefiore Hudson Valley Collaborative (MHVC) is offering a webinar series on care management for patients with diabetes. This training is part of MHVC's cross project training strategy that promotes the ongoing transformation of healthcare; specifically in building competencies in care management of complex cases.

Participants will receive fundamental information on diabetes, its underlying cause and disease process, medical management, and patient education as it integrates to case management process. Participants are not required to attend all sessions.

About This Training

By the end of this training, the learner will:

Module 1: Epidemiology	<ul style="list-style-type: none"> Define diabetes. Discuss the prevalence of diabetes and its economic impact. List the risk factors of diabetes. Explain the disease process for diabetes.
Module 2: Pharmacology	<ul style="list-style-type: none"> Identify the medications used in diabetes management. Describe the actions, side effects and implications of insulin and oral anti-diabetic medications. Discuss case management strategies in improving medication adherence in individuals with diabetes.
Module 3: Diabetes Treatment Modalities and Self-Management	<ul style="list-style-type: none"> Discuss evidence-based medical management and interventions. Discuss self-management practices.
Module 4: Documentation and Case Management	<ul style="list-style-type: none"> Discuss the AADE 7 and implications for adherence which include medication, diet, exercise, self-monitoring of glucose levels, coping with the disease and the change of lifestyle, problem solving and reducing risk and identifying adherence challenges. Review case management assessment and intervention specific to the individual with diabetes.
