Montefiore Hudson Valley Collaborative (MHVC) is offering multiple instructor-led training on Brief Action Planning in 2018. This training is part of MHVC’s cross project training strategy to help build patient-centered self-management support skills.

About This Training

Brief Action Planning is a structured way of interacting with individuals interested in making a concrete action plan for some aspect of their health. It is based on the principles and practice of Motivational Interviewing and is supported by evidence from behavioral science and self-management support. The core skills of Brief Action Planning can be learned by anyone interested in supporting others to make change.

By the end of this training, the learner will:

- Utilize Brief Action Planning (BAP) skills to engage patients and support self-management.
- Discuss basic principles of Motivational Interviewing (MI).
- Utilize Brief Action Planning (BAP) tips to improve patient adherence.
